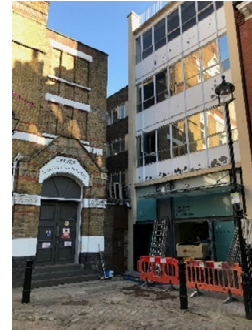

Welcome to our latest newsletter, its purpose is to give you regular updates of what we the contractors are getting up to in the building. These newsletters are produced on a monthly basis to let you know what is going on and how it may affect you.

We are taking all practical precautions to mitigate the effect of the works on the surrounding neighbours; however, it is inevitable that due to the nature of the works occasionally some inconvenience may be experienced.

We would like to take this opportunity to thank you for your understanding and patience during the construction works at 45 Fouberts Place and for any inconvenience that may be experienced.

### **Brief Overview of the Project.**

Design and construction of a two storey extension and category A office fit out with structural alterations including beam strengthening and a steel sway frame, underpinning to basement foundations, lightweight extensions at 4th and 5th floor levels with a new amenity terrace and extension to the external fire escape stair, new roofing at all levels, a new facade to the Foubert's Place elevation, minor repairs to the external fabric of the building, removal of concrete casings to steel beams to expose the lower flange, replacement of all windows and external doors, new toilet blocks and reception, internal finishes and decorations throughout, new building services throughout, new lifts, building name signage and new incoming mains water supply and ducts for all statutory services.

### **Works we intend to carry out in August 2023**

- Installation of new window frames and glazing on GF – Level 5.
- Deliveries and waste away.
- Install rain screen cladding and architectural metalwork.
- Continuing with internal decorations and finishes.
- Striking scaffold to 46 & 47 Great Marlborough St elevation
- Install decking to level 4 terrace.
- New incoming mains water supply.
- HIAB lift to roof 21<sup>st</sup> August TBC

### **Working Hours**

The works will be undertaken between the hours of 8am and 6pm from Monday to Friday and 8am to 1pm on Saturday.

Resource management on 45 Fouberts Place falls under the scope of Faithdean's ISO 14001:2015 certified environmental management system. Typically, we work towards a 98% ratio of diversion from landfill.
